S.R.O.No.232/80- In exercise of the powers conferred by sub section (2) of section 4 of the Census Act, 1948 (Central Act 37 of 1948) , The Government of Kerala hereby appoint the Town Planner, Idukki as Census Officer to take, or aid in, or supervise the taking of the census within the area declared to be a controlled area for the purposes of the Travancore Town and Country Planning Act, 1120 by Notification G.O.MS.No 303/76/LA/SWD dated the 21st December, 1976, published as S.R.O.No 1324/76 in the Kerala Gazette Extraordinary No 751 dated the 31st December 1976.

S.R.O.No. 283/80—Under subsection (3) of section 4 of the Census Act, 1948(Central Act 37 of 1948) , the Government of Kerala hereby authorize the Town Planner, Idukki to sign a declaration of writing that any person has been duly appointed as Census Officer for the area declared to be a controlled area for the purpose of the Travancore Town and Country Planning Act, 1120by Notification G.O.MS.No 303/76/LA & SWD dated the 21st December, 1976, published as S.R.O No.1324/76 in the Kerala Gazette Extraordinary No 751 dated the 31st December 1976.

S.R.O.No. 284/80—In exercise of the powers conferred by subsection (4) of section 4 of the Census Act, 1948 (Central Act 37 of 1948), the Government of Kerala hereby delegate to the Town Planner, Idukki the power of appointing Census Officers within the area declared to be a controlled area .for the purpose of the Travancore Town and Country Planning Act, 1120 by Notification .O.MS.No.303/76/LA& SWD dated the 21st December, 1976 published as S.R.O.No 1324/76 in the Kerala Gazette Extraordinary No. 751 dated the 31st December, 1976.

S.R.O.No. 285/80- Under section 7 of the Census Act, 1948 (Central Act 37 of 1948), the Government of Kerala hereby appoint the Town Planner, Idukki as the authority for the area declared to be a controlled area for the purpose of the Travancore Town And Country Planning Act 1120 by Notification G.O.MS.No 303/76/LA & SWD dated the 21st December, 1976, published as S.R.O.No 1324/6 in the Kerala Gazette Extraordinary No 751 dated the 31st December, 1976, for the purposes of the said section.

Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport.)

The Government of India have notified under section 3 of the Census Act, 1948, that the Census of population of India shall be taken in 1981 with reference date as Ist March 1981. Under the relevant sections of the Census Act the State Government have to appoint officers of specified area and to authorize them to appoint the required Census Officer under them to take or aid in, or supervise the taking of the Census within the local areas, specified under their control. Accordingly notifications were issued as S.R.Nos. 1054/79, 1055/79, 1056/79, 1057/79 and 1058/79. Now it has been decided to appoint the Town Planner, Idukki as Census Officer exclusively for the Idukki Township area. These notifications are issued as achieve the above objective.
