S.R.O.No. 1057/80.- In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following further amendments to the Special Rules for the Kerala Last Grade Service published under Notification G.O.(P) No.82 Public (Rules) Department dated the 8th March, 1966, in Part I of the Kerala Gazette No. 14 dated the 5th April, 1966, as subsequently amended namely:-

AMENDMENTS

In the said rules,-

(1) in rules, 1, in category 2 after item (b), the following item shall be inserted, namely:-

“(bb) Messenger in the Administrative Secretariat.”

(2) in rule 8,-

(i) in the Table under sub- rule (b), after the item “ Head Gardner in the Government Secretariat” in column (1) and the entries against it is column (2), the following item and entries shall respectively be inserted , namely ;-

“Messenger in the
Administrative

1. Must be an Ex- Service man.

2. Must be able to read and write Malayalam or Tamil or Kannada.”

(ii) in clause (2) of the Notes, after the words “ the posts of “, the words “ Messenger in the Administrative Secretariat.” Shall be inserted.
