Sub:- Public Services- Drivers of Departmental. Motor vehicles-Appointment of – Instructions reiverated.

In the G.O read as second paper, Government have prescribed a Scheme for selection of candidates for appointment as Drivers of Motor Vehicles. In Department to other than Police Department, by transfer from other classes / categories in other service.

- 2. In the G.O first cited, Government have ordered that when drivers of Departmental vehicles are granted leave including Casual. Leave for short periods not exceeding 15 days the Officers of the Departments concerned (s) stating authorities may appoint Private Drivers on Daily wages on their own responsibility for the proper use of the vehicles and for the safety of the accessories. The G.O. size requires that private drivers on daily wages should be appointed only when the officers concerned are convince that there in urgent accessity for taking out the vehicles and the work cannot be managed by some internal arrangements.
- 3. In the Circular fourth cited the instructions issued in the above G.O's were reinterated and the Heads of Departments were requested to follow the instructions scrupulously.
- 4. The Kerala Government Drivers Association in their Memorandum fifth cited have complained inter alia that a number of Drivers are working in the various Departments on daily wages etc. Government therefore issue the following further instructions in the matter:-
  - (1) Drivers should not be appointed on daily wages beyond a period of 15 days under any circumstances. The instructions already issued in the G.O's. cited should be followed strictly. The appointing authorities will be personally held responsible for any violation of these instructions.
  - (2) Wherever sanction for the purchase of Vehicles is sought for action should simultaneously be taken for the creation of a post of Driver also.

(3) The Services of all the Drivers on daily wages who are continuing beyond fifteen days may be terminated fourth with and regular appointment may, if necessary, be made to such vacancies.
