## NOTIFICATION

S.R.O.No. 799/81.- In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following amendment to the Special Rules for the Kerala Part-time Contingent Service Published under Notification No. G.O.(P) No. 152/75/Pd dated the 2<sup>nd</sup> August, 1975 as S.R.O. No. 742/75 in Part I of the Kerala Gazette No. 34 dated the 2<sup>nd</sup> September, 1975, as subsequently amended, namely:-

## AMENDMENT

IN the said Rules, for rules 15, the following shall be substituted, namely:-

"15. Superannuation – a member of the service shall retire on the last day of the month in which he completes the age of 70 years."

This amendment shall be deemed to have come into force with effect from the 3<sup>rd</sup> November, 1980.

(This note is not part of the Notification but is intended to indicate general purport)

In G.O. (P) No. 831/80/(253)/Fin. Dated 3-11-1980 Government issued executive orders that all Part time contingent employees who have already attained the age of 70 years and those who complete the age of 70 years on or before 30-11-1980, shall retire from service on 30-11-1980 and that other Part-time contingent employees shall retire on the last day of the month in which they compete the age 70 years. This has necessitated amendment to Rules 15 of the Special Rules for the Kerala Part-time Contingent Service. This notification is intended to achieve the above object.
