## NOTIFICATION

S.R.O.No. 528/85 – In exercise of the powers conferred by subsection (I) of section 2 of the Kerala Public Services Act, 1958 (19 of 1968) The Government of Kerala hereby make the following amendments to the special Rules for the Kerla part-time Contingent Service published under Notification G.O (P) No.152/75/PD dt. The 2<sup>nd</sup> August 1975 as S.R.O No. 742/75 in part I or the Kerala Gazette No.34 dated the 2<sup>nd</sup> September, 1975, as subsequently amended, namely:-

# AMENDMENTS.

In the said Rules, in rule 14:-

in clause (b) for the words "thirty days" the words "one hundred and twenty days" shall be (i) substituted;

(2) in clause © for the first sentence, the following sentence shall be substituted, namely:-

"Maternity Leave for three months or leave for abortion or miscarriage for six weeks, as the cause may be, to female employees with full pay and Dearness allowance for the period".

The amendment to clause (b) of rule 14 shall be deemed to have come into force with effect from the 12<sup>th</sup> July, 1984 and that to clause (e) of the said rules shall be deemed to have come into force with the effect from the 25<sup>th</sup> October 1983.

#### **EXPLANATORY NOTE**

(This note does not form part of the notification, but is intended to indicate its general purport)

In G.O.MS.No 233/84/GAD dt. 12-7-1984, Government issued orders enhancing the period of leave without allowances admissible to the part-time contingent employees in a calendar year from thirty days to one hundred and twenty days. Orders have also been issued G.O.(P) No. 335/84/588/Fin. Dt.10-7-1934 that female part time Contingent employees will be allowed six weeks leave for abortion or miscarriage with full pay and D.A. with effect from 25-10-1983. These orders have necessitated amendents to rule 14 of the Special Rules for Kerala Part time Contingent Service. This notification is intended to achieve the above object.
