ORDER

In the read as Ist paper above Government ordered that whenever recruitment tets are conducted by the Kerala Public Service commission in Malayalam, option shall be given to all candidates to take the tests in one of the languages viz, Tamil, Kannada, Hindi or English. The selected candidates who had taken the tests in languages other than Malayalam will be required to pass a language test in Malayalam for completion of their probation. The syllabus for the Languages Test in Malayalam was prescribed by the Government as per the G.O read as 2nd paper above. The syllabus of the test was simplified as per the G.O's 3rd, 4th and 5th cited. As per the existing orders the syllabus prescribed for the second class language test is as follows:

Written (Part A) – Translating an easy passage of English prose relating to Indian Subjects which contains no words that have not familiar equivalents in Malaayalam. (The passage may be of VII Standard).

Part B:-Conversing with accuracy and fluency in Malayalam

The Kerala Public Service commission in their letter read above3 has reported to Government that even the standard of the test has been lowered to some extent, candidates residing in linguistic minority areas especially in Kasaragod area still find it difficult to find through the test. The Commission has expressed the view that a reduction in the percentage of marks now insisted for a pass Parts A and B of the test will be of much help to mitigate the hardship now being experienced by the candidates and have advised Government to fix an aggregate minimum of 35% ie 70 marks out of 200 for both the parts taken together with a separated minimum of 30% in each part.

Governments have considered the advice of the Commission in all the aspects. Government accept the advice of the Commission in this matter and are pleased to fix in modification of the orders issued in the G.O 4th paper cited , that an aggregate minimum of 35% ie. 70 marks out of 200marks for both the pasts taken together with a separate minimum of 30% in each part (Parts "A" & "B") will suffice for a pass in the language test in Malayalam.
