S.R.O. No1706/87- In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act,1968 (19 of 1968), read with section 3 therefore , the government of Kerala hereby make the following amendments to the Special rules for the Kerala Last Grade Service published under Notification G.O.(P) No 82 Public (Rules) Department dated the 8<sup>th</sup> March, 1966, in Part I of the Kerala Gazette No. 14 dated the 5<sup>th</sup> April, 1966, as subsequently amended, namely:-

**AMENDMENTS**

In the said rules,-

1. in rule 1,-

- (a) in item (b) of category1, the words “Dispensary Attendant” shall be omitted.
- (b) in category4, after item (v) the following item shall be inserted, namely:-
- (w) Watcher-cum-Cook in the Public Works Department.
- (x) Sweeper-cum-Night Watchman in the Kerala Institute for Research, Training and Development Studies of Scheduled Castes and Scheduled Tribes.
- (y) Night Watcher-cum-Sweeper in the Stationary Department”;
- (c) After category 6 and before the Note, the following categories shall be inserted, namely:-

“*Category7:*

Field workers in the Health Services Department.

*Category 8:*

Process servers in the Judicial Department.

*Category 9:*

Hospital Attendant Grade I in the Health Services Department”

2. In sub-rule (a) of rule5, after the entries under Category 6 the following shall be inserted, namely:-

*Category 7:*

- (i) Appointment by transfer from posts in the Health Service Department carrying similar or identical scaled\\$ of pay;
- (ii) In the absence of qualifying persons under item (i) above by promotion from posts in the Health Services Departments.
- (iii) In the absence of qualifying persons under items
  - (i) and (ii) above, by direct recruitment.

*Category8:-*

- (ii) By appointment from among qualified persons in the Judicial Department carrying similar or identical scales of pay, according to seniority and willingness;

OR

- (iii) In the absence of qualified persons under item (i) above by direct Recruitment.

*Category 9:-*

By promotion from Hospital Attendant Grade Ii in the Department”.

3. In rule 8, in the table under sub rule (b), after the item “Peon in the Lottery Office, Calcutta” in column (1) and the entries against it in column (2), the following items and entries shall be inserted, namely:-

Field Workers in the Health  
Service Department

1. Must have studied up to VIII the standard or its equivalent.
2. Should have good physique and must be free From physical deformity and diseases of any Description.

Note:- Physical fitness shall be certified by a Medical officer not below the rank of an Assistant surgeon.

Process servers in the judicial  
Department

1. Must have studied up to 10<sup>th</sup> Standard.
2. For direct recruitment of males to the post of Process Servers, ability to ride bicycle shall be an essential qualification.

The amendments in respect of “Category 7 Field Worker in the Health Service Department’ shall be deemed to have come into force with effect from the 27<sup>th</sup> August, 1973.

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have decided to incorporate the following posts in the Special Rules for the Kerala Last Grade Service.

1. Watcher- cum- Cook in the Public Works Department.
2. Sweeper- cum- Night Watchman in the Kerala Institute for Research, Training and Development Studies of Scheduled Casts and Scheduled Tribes.
3. Night Watcher- cum- Sweeper in the stationery Department.

It has also been decided to include the posts of field Workers in the Health Services Department, Process Servers in the Judicial Department and Hospital Attendant Grade I of the Health Services Departments as separate categories prescribing its methods of appointment and qualifications. It has also been decided to delete the post of Dispensary Attendant from the Special Rules for the Kerala Last Grade Services. These have necessitated amendment for the Special Rules. This notification is intended to achieve the above object.
