ORDER

In the government Order read, the rates remuneration of part time Contingent Employees were revised as follows:-

Based on the above categorization, the 4th Kerala Pay Commission revised the rate of remuneration as shown below:-

- 2. The existing categorization does not specify the minimum or maximum area to be swept or cleaned by a part-time Contingent Employee. The Committee of Secretaries has also recently suggested that there is no necessity to sanction part-time Contingent posts in offices where the area to be swept or cleaned is comparatively small.
- Accordingly Government are pleased to modify sub para (i) under para I of the orders 3. issued in the Government Order read above as follows:-

"The existing rates of remuneration of part-time Contingent Employees shall be revised as shown below with immediate effect:-

Area to be swept/cleaned 100sq.metre and above but below	Pay	D.A.	Total
400sq.metres	Rs.225	Rs.64	Rs. 289
400sq.metre and above but below 800sq.metres	Rs.283	Rs.70	Rs.353

Hereafter, all part-time Contingent Employees shall be accommodated against sanctioned posts, in one of the categories detailed above provided that the area to be swept/cleaned is 100sq.metres or above. In such cases, the Heads of Departments shall take immediate steps to obtain Government sanction creating part-time Contingent posts in one of the categories mentioned, based on the area to be swept / cleaned in each case and the existing incumbents accommodated against such posts. In small offices like Village Offices where the area to be swept / cleaned is below 100sq.metre, the post of Part time Sweeper need not be created, instead the sweeping or cleaning work will be done on payment of a fixed remuneration of Rs. 50 p.m.from the provision under "Office Expenses".
