**S. R. O. No. 427/2011.**—In exercise of the powers conferred by Section 58 D of the Wildlife (Protection) Act, 1972 (Central Act 53 of 1972), the Government of Kerala hereby authorize the Principal Chief Conservator of Forests and Chief Wildlife Warden, Additional Principal Chief Conservator of Forests, Regional North, Kozhikode, Additional Principal Chief Conservator of Forests, Regional South, Kollam and Chief Conservator of Forests (Bio Diversity Cell), Thiruvananthapuram as Competent Authorities in their respective jurisdiction to perform the functions as such under the provisions of Chapter VI-A of the said Act.

## II

**S. R. O. No. 428/2011.**—In exercise of the powers conferred by section 58 G of the Wildlife (Protection) Act, 1972 (Central Act 53 of 1972), the Government of Kerala hereby appoint all Conservators of Forests/Chief Conservators of Forests in charge of Territorial circles (Southern Circle, Kollam, High Range Circle, Kottayam, Central Circle, Thrissur, Eastern Circle, Palakkad and Northern Circle, Kannur) and all Conservators of Forests/Chief Conservators of Forests in charge of Wildlife Circles (Agasthyavanam Biological Park Circle, Thiruvananthapuram, Field Director, Circle Tiger Project, Kottayam and Wildlife Circle, Palakkad) as Administrators to perform the functions under the provisions of Chapter VI-A of the said Act.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per section 58 D of the Wildlife (Protection) Act, 1972 (Central Act 53 of 1972) the State Government may, by order published in the official Gazette, authorize any officer not below the rank of Chief Conservator of Forests to perform the functions of the Competent Authority under chapter VI-A. As per section 58G of the said Act the State Government may, by order publish in the official gazette, appoint as many of its officers (not below the rank of Conservator of Forests) as it thinks fit, to perform the functions as an Administrator under chapter VI-A of the said Act to manage the property forfeited to the Government. The State Government have decided to authorize Additional Principal Chief Conservator of Forests, Regional North, Kozhikode, Additional Principal Chief Conservator of Forests, Regional South, Kollam, Chief Conservator of Forests (Bio Diversity Cell), Thiruvananthapuram and the Principal Chief Conservator of Forests and Chief Wildlife Warden as Competent

Authorities to forfeit property derived from illegal hunting and trade to the State Government and to appoint all Conservator of Forests/Chief Conservator of Forests in charge of Territorial Circles (Southern Circle, Kollam, High Range Circle, Kottayam, Central Circle, Thrissur, Eastern Circle, Palakkad and Northern Circle, Kannur) and all Conservators of Forests/Chief Conservator of Forests in charge of Wildlife Circles (Agasthyavanam Biological Park Circle, Thiruvananthapuram, Field Director Circle, Tiger Project, Kottayam and Wildlife Circle, Palakkad) as Administrators to receive and manage the properties that stand forfeited to the State Government and to perform the functions under Chapter VI-A of the said Act.

The notification is intended to achieve the above object.
