ORDER

The Chief Conservator of Forests has reported that the sale of right of collection and remoal of tree growth in sub coupes VII to II of the abover coupe was attempted several times but without success. It is stated that transport of produce from the coupe is difficult in view of the difficulty in constructing reads there. In error to attract bidders the Chief Conservator of Forests has requested section to inclusive special condition as above below in the sale notice allowing charcoal burning in the above sub coupes.

- i) Charcoal burning will be allowed. He need below 30 centimeters is girth at the thinner and will be allowed to be collected and removed either as timber or an firewood or for burning charcoal. Charcoal burning will be allowed only in plots of about the hectares in each sub coupe specially set apart for the purposes and pointed out by the Range Officer.
- ii) The purchaser is based to do slash felling of all trees and other growth in the coupe i.e.all stamps, under growth, bamboos and trees shall be out flash with the ground and all grade uprooted and the debris evently spread and allowed to dry. We shall also burn and reburn such debrie completely so as to leave as unburnt material. If it is found that any or all of those works are not done in time to the complete satisfaction of the department, they shall be done by such agency on the Divl. Forest Officer may decide, at the risk and loss of the purchaser and the entire cost recovered from the purchaser and the agency doing the mark reinbursed besides the purchaser being penalised at Rs.62/- per hectare for the default.

In the circumstances Government accept the Chief Conservator's proposal and order accordingly.
