## ORDER OF KT-5616/74 dt.9-4-1974

In accordance with the decision taken by the Hon'ble Minister for Finance in the conference held at Kottayam on 22-2-1974 the sale of the right of collection and removal of timber and Firewood from all the enumerated trees in the above coupes excluding teak and Rosewood those trees marked for Depot delivery was notified by the Divl. Forest Officer, Kottayam in Government Gazette dt. 19-3-74 on pages 180 to 182 and in two Malayalam dailies viz. Malayala Manorama dt.21-3-74 and Deepika dt 19-3-74 fixing the date of auction as 29-3-1974.

In response to the above notification the sale was conducted by the Divl. Forest officer at the scheduled time. It is reported that 63 persons deposited E.M.D. and participated in the auction. The sale was knocked down in the name of the highest bidders as shown below:
