Accordingly Sri. Kurian Mathai executed agreement with the Divl. Forest Officer, Kottayam on 17-10-'73 furnishing a security of Rs.20,000/-

The Contractor Sri. Kurian Mathai has now applied for permission to transfer the work in the name of Sri. K.M. Sayed Mohammed, Keeriathottam Nadackal, Erattupetta as he is unable to carry out the work due to illness and have submitted a joint petition read as IInd paper above. In the petition, Sri. K.M. Sayed Mohammed has expressed his willingness to take up the work. The Divl. Forest Officer, Kottayam in his report cited above as IIIrd paper has recommended to transfer the contract to Sri. K.M.Sayed Mohammad with all assets and liabilities in respect of the contract.

In the circumstances stated above, and in view of the provision contained in condition 20 of the Agreement dt.17-10-1973 executed by Sri Kurian Mathai, I, Shri K.G. Vasudevan, Conservator of Forests, Central Circle, Trichur hereby accord sanction for the transfer of the contract entered with by Sri. Kurian Mathai in the name of Sri. K.M.Sayed Mohammad provided the transferee executes a fresh agreement with due security embodying all the terms and conditions of the original agreement dt.17-10-'73 and granting period till 16-4-1975, i.e., the period of the original contract.
