

PROCEEDINGS OF THE CONSERVATOR OF FORESTS, CENTRAL CIRCLE, TRICHUR.

Sub:- Working down timber and Teak and Rosewood firewood from K.T.F.S. Coupe No.XVIII in Pariyaram Range to Chettikulam and Chalakudy Depots.

Ref:- Chalakudy Divl. Forest Officer's report on CC1-10454/72 dated 27-9-73.

ORDER NO.CH. 12337/73 DATED 24-10-1973

Tenders were invited to be received by 3 PM on 24-9-73, by the Divisional Forest Officer, Chalakudy for working down about 14.594 cum. of Rosewood timber and 2158.419 cum. of timber of other species and 15 tonnes of Teak and Rosewood firewood from K.T.F.S. coupe No.XVIII in Periyaram-Range and delivery and stacking of the Rosewood Timber at Chalakudy Depot and Timber of other species and firewood at Chettikulam Depot.

The Tender notification was published in Gazette dated 4-9-73 pages 449 and 450 of Forest sheet and in dailies Mathrubhumi Calicut edition on 15-9-73 and Cochin edition dated 16-9-73 and Express, Trichur dated 15-9-1973.

Twenty three persons purchased tender forms of whom nineteen persons tendered for the work. The rates offered by the tenderers are as follows:-

It may be seen from the above, the tender of Sri. P.P.Devassykutty, (Sl.No.19) quoting 78% of the departmental standard rate is the lowest. The Divisional Forest Officer has reported that the rate offered by the lowest tenderer is advantageous to Government and has recommended to award the work to him.

Under the above circumstances, and having convenced that there has been adequate publicity and that the rate offered is reasonable, I, Sri. K.G.Vasudevan, Conservator of Forests, Central Circle, Trichur, hereby accept the tender of Sri. P.P.Devassykutty, Puthanpurakkal House, Chalakudy quoting the 78% of the Departmental standard rates and the work is awarded in his name.

The Divisional Forest Officer will pursue further action for execution of agreement. 19 (Nineteen) Tenders in original are returned herewith.
