ORDER

Sanction is accorded for the supply of 2000 M3 (two thousands Cubicc metre) of hardwood such as Earimaruthu/Thambavoor/Venteak/Maruthu/Aliyini/Akil/Venga/Kadukka/Kalpyne/Theetiplave/Irimbirakka/Myla/Irul/Thambakm/Nangu (Vainavu) to the Public Works Department, Union Territory of Lakshadweep from the Forest Depots subject to the conditions given below:-

- 1. Supply of timber will be made only under Government of India specification.
- 2. Supply will be made subject to the availability.
- 3. Value of timber supplied should be remitted in advances.
- 4. The administration of the Union Territory of Lakshadweep will make their own arrangement to lift the timber from the concerned Depots their own cost.
- 5. Value should be realized at Government of India rates prevalent at the timber of supply.
- 6. Administration will pay 5% overhead charges if the Selection is done by their represente tives of 7% over hhead charges if the selection is made by the officials of the Kerala Forest Department.
- 7. For belsted ren oval of the timber allotted ground rent will be levied as per rules contained in suction sale notification.
- 8. The timber supplied should be removed within the production year itself ie. On or before 31-10-1986 and the validity period of the timber sanctioned will expire by 31-10-1986.
- 9. Supply will be effected only on the basis that the Administration has no amount due to the Forest Environment and Wild Life Department by way of consumption if any.,
