Government have already issued orders with effect that permits for bamboo or rattan for individuals will be given only to those who are not members of industrial co-operative Society on the basis of the certificate issued by the District Industries Officer. Members of such Cooperative Societies are to pool their requirements of bamboo and rattan and supply will be made on the basis of the District Industries Officer's Certificate on the Society. The petitioner organization may get the required certificate from the District Industries Officer and purchase the requirements from the Contractors at the concessional rate allowed.

The Christian Charity Campaign is a purely social organization which has been brought into existence by the earnest endeavor of the College student of this town, the aim of this organization being the uplift of the poor.

Moved by this deplorable sight, we thought it up to us to come to their relief and render them as much help as possible by giving them the raw materials required on credit basis and also find out profitable markets for the articles manufactured. In this attempt the organization has no motive for profit, and hence out of the sale proceeds the manufacturers will get all the sales amount less the actual amount advanced as price of the materials supplied. The organization has collected sufficient funds for the purpose and the members are fly optimistic about the success of this attempt, which will be run on a co-operative basis.

At the initial stage we will require a monthly quota of 500 bamboos, 10000 cottan and 250 canes. We have begun construction of a shed for the purpose and are ready to buy the materials mentioned above as soon as it is sanctioned and we assure that we will mange the affair most efficiently without any abuse.

Hence we humbly request you to issue the necessary pass in the name of the Director of the said association for the purchase of 500 bamboos, 10000 eettas 250 canes monthly.

We approached Mr. M.P. George, Chief Conservator of Forests at his Chithirapuram Camp, near Munnar for the name and according to advice and directions we are approaching the Hon. Minister.
