Sub: Contractors' Names - Registering of

In modification of the Notification dated, 1-4-'59 (published in the Government Gazette dated 14-4-'59/24th Chaitra 1881 (Saka),Forest sheet) the following revised notification is published for general information of those who wish to register their names if the Divisional Forests Offices for participating in tenders for Forest works and auction sales.

2. A Permanent Register of Contractors is proposed to be maintained in such Forest Division Office and any contractor who wishes to register his name with the3 Department will be allowed to do so one payment of a permanent earnest money of Rs.50 in a forest Division so as to enable him to under take work in that particular Division. If the contractor wishes to take un works in more than and division he will have to deposit Rs.50 in each of the Divisions. For renewal every year thereafter, a fee of Rupee one shall be levied and the financial year shall be adopted for registration of names in the Register of contractors. Change of address will on written intimation to the Divisional Forest Officer, be noted in the Register on payment of a fee of Rupee one.

3. Instead of three registers as stated in para 2 of the Notification dieted above, two registers will be now maintained in the Divisional Forest Office, viz., one register for registering the names of all contractors who take uppercase contracts such as purchase of tree growth timber or any other produce in auction in range or depots, and another for works contracts such as supply contracts, road works building works transport etc. All the contracts of the Department shall be included in either of the two items as the case may be.

4. The auction sale and tender notices of works shall be posted to all contractors under certificate of costing according to the nature of the work for which they havew registered their names in the divisional Forest Officer's office. In the case of contractors

Resident in the Headquarters of the Divisional Forest Officer or Range Officer, delivery of notices will be made by local delivery.

- 5. (a) The sales in respect of condemned articles of stores, confiscated produces in forest cases and sales of forest produces the value of which does not exceed Rs.100 will be published by circulating the sale notice locally.
 - (b) The sales of produces valued up to Rs.1000/- shall be published ion the Gazette in addition to the issue of individual notices to the Registered contractors of the District under certificate of costing.
 - (c) For sales of forest produces etc., and notification for tender for works when the value of the produce or the works involved exceeds Rs.1000 but is below Rs.2,500 individual notices shall be issued to the contractors of the District under certificate of posting in addition to the notification in the Gazette and publication in two local dailies.
 - (d) Advertisements in not more than two local dailies may be done in the case of works valued over Rs.2,500 and sales or tenders valued at Rs.5000 and over, in addition to the publication in the Gazette and sending individual notices to the registered contractors of the Circle or the Division.
 - (e) Such of the names and addresses of contractors who have defaulted or been blacklisted by Conservator of Forests or Chief Conservator of Forests shall be deleted from the Register.
