The chief conservator of Forest is informed that the orders issued in government circular Memorandum No. 24692/Coml/3/62/Fin, dated 8-6-1962 will not be applicable to the deposits made in the District Co- Operative banks as the Bank Guarantee scheme is applicable only to the Scheduled Banks. Since the Co-operative Banks are kept outside the purview of the Bank Guarantee scheme. There is no necessity for their Deposits Receipts being supported by confirmedly advices from the Reserve Bank of India for acceptance as security by confirmatory advices from the Reserve Bank of India for acceptance as security and earnest money deposits. It may also be noted that "Central Co-Operative Bank" is another name for "District Co-Operative bank". The Reserve Bank of India will ot issue any confirmatory advices in respect of the Deposit Receipts of co-operative Banks are kept outside the purview of the Bank Guarantee Scheme. The acceptance of Deposit Receipts of Co-Operative Banks may therefore be done in accordance with G.O (Ms) 103/65/AD dated 18-2-1965 whereby the orders in G.O (MS) No. 878/61/AD dated 17-8-1961 have been further extended up to the end of March 1966. In the light of the above orders, the deposit receipt furnished by the contractor can be accepted.
