FORESTS-Extension of contracts-penalty rate-enhancement of orders issued.

ORDER

The Chief Conservator of Forests has forwarded proposals to Govt. for enhancement of powers regarding granting extension of period of Forest Contracts on realization of penalty and for enhancement of powers and fixing of penalty for extension of currency of passes for removal of softwood timber within the contract period which include the extension period of contract also.

The following are the items for which enhancement of rates of penalties has been proposed:-

1. <u>TIMBER:-</u>

The existing rate of penalty is a flat of Rs.1.75 per cum. for the quantity delivered at the Depot during the during the period of extension. The Chief conservator of Forests has proposed to enhance the rate of penalty as follows:-

- 1. Rs.2/- per cum .for the quantity of timber delivered at the Depot during the one month extension granted by the Divl.Forest officer.
- 2. Rs.2.50 per cum.for the quantity delivered at Depot during the two months extension granted by the Conservator of Forests.
- 3. Rs.3/- per cum.for the quantity delivered at Depot during the 3 months extension granted by the Chief conservator of Forests, Govt.approve the above rates propose by the Chief Conservator of Forests and order accordingly.

II FIREWOOD:-

The existing rate of penalty is Rs.0.50 per tonne for the quantity delivered at the depot during the period of extension. The proposal of the Chief conservator of Forests is to enhance the rate of penalty as follows:-

- 1. Rs.1/- per tonne in respect of the extension granted by the Div. Forest Officers.
- 2. Rs.1.25 per tonne in respect of the extension granted by the Conservator of Forests
- 3. Rs.10.0 per tonne in respect of the extension granted by the Chief Conservator of Forests.

Govt. approve the above rates recommended by the Chief Conservator of Forests and order accordingly

III SOFTWOOD INCLUDING MATCHWOOD:-

Regarding softwood, it has been decided that the penalty for the first 15 days after the grace period shall Rs.2/- per cubic metre. The Conservator of Forest will he empowered to grant extension for a period up to 30 days after the Divl. Forest Officer has granted extension for 15 days. During this period, the penalty will be Rs.3.50 per cum. The Chief Conservator of Forests will be empowered for the first 15 days, the penalty will be Rs.5.25 per cum. And beyond that period Rs.7/- per cum. The pattern for extension for softwood will he as shown below:-
