## <u>ORDER</u>

In the G.O. read as second paper above, Government have sanctioned the concessions admissible to the officers of this Government in the matter of occupation of the Guest Houses and Tourist Bungalows under the control of the Tourist Department beings extended to the officers of the government of India visiting the state on duty and to these officers of the Government of India who are working in this States. But similar or concessions were not being extended to the officers of this Government in the matter of occupation of the Central Government Hostel. Nizam Palace at Calcutta when they have to visit Calcutta on official business, while at the same time they are being extended to the Officers of State Governments Officers, Punjab etc. The matter may therefore taken up with the Government of India requested from to extend the concessions to the offices of this Government also when they stay in the Central Government Hostel at Calcutta.

2. The Government of India, Ministry of works and Housing have in their letter read as  $2^{nd}$  paper above, intimated this Government that, with immediate effect the concessional rent as is charged from the Central Government Officers will be charged from the officers of this Government for their stay while on duty in the Central Government Hostels/Inspection. Bungalows/Dark Bungalow Rest Houses maintained by the Central P.W.D provided the Government of Kerala charge rent from a Central Government Officer for his stay in similar type of accommodation here, as in chargeable from the officers of the Government of Kerala. The period of such stay in either case is however restricted to days at a time.

3. In the above circumstances the Government are pleased to order that in additions to the Guest Houses and Tourist Bungalow under the Tourist Department, the concessions admissible to the officers of this Government will be extended to the Government of India officers on duty in this matter of occupation of Rest Houses, camp sheds inspection Bungalow and project houses also.

Such stay in these therefore including the Guest Houses and Tourist Bungalow will be limited to a period of ten days at a time.
