ORDER

According to rule 4(a) of the 'Rules for the Reservation and Occupation etc. of Rest Houses, Inspections Bungalows, Campsheds if a person who reserved the room does not turn up within six hours of the first day of reservation, the room can be allotted to the applicants in the order of priority. In rule 3 (c) a 'day' is defined as 24 hours calculated from the hour of arrival of the occupants. In view of the difficulty pointed out to implement rule 4 (8) in the light of the provision under rule 3 (c) the chief Engineer (Genl., Buildings & Roads) has suggested that the definition of 'day' given in rule 3 (c) may be modified to mean 24 hours calculated from 9 A.M. of a calendar day so that 6 hours grace time stipulated in rules 4 (8) may reckoned easily. In that case, as per rule 4 (8) the room can be allotted to another applicant if the original applicant does not turn up till 3 P.M. on the day of reservation.

2. Government have examined the matter in consultation with the District Collectors and find that rules require modification to avoid the situation where rooms are kept vacant at loss to Government when there are applicants waiting, merely due to delay in occupation by the original allottees. Therefore Government are pleased to amend the 'Rules for the Reservation, Occupation etc. of Class II Travellers Bungalows, Inspection, Bungalows & Campshed's as follows:

Amendments

In the said rule,

- (1) In rule 3, for the sub rule (c) the following will be substituted.
- (c) "day" means a whole day of 24 hours calculated from the expected time of arrivals of allottee".
- (2) after rule 4(1), the following note will be added: "The applicants should give the expected time of arrival also in the application".
- (3) in rule 4, for the sub rule 8, the following will be substituted.
- n8. If the person who reserved the room does not turn up to occupy the same within six hours of his expected time of arrival, the allotment can be cancelled and the room reallotted in favour of the next applicant in the order of the priority/precedence".
