Sub:- Land assignment rules (1964) Belt area of 2 to 3 chains of land arrounded reserved forests reservation of instructions issued.

It is seen from the Govt. Memorandum No, 61811/A3/65/Ad dt. 26-4-66 from the Revenue Department to the Secy. To Board of Revenue (Copy of which is enclosed) that the forest Department will have to take action for planting fact growing species of trees in the belt area in between assigned lands and reserve forest boundaries. While proposing a species for planting around reserved forests the following points have to taken into consideration.

- 1. The species should be fast growing as proposed in Govt. memorandum its
- 2. It should be of some specific utility, economically acceptable and apparently suited to meet some of the local demands.
- 3. It should not demand close attention and care and frequent tending after initial stage. The boundaries of reserved forests are likely to be for off from the range headquarters and hence a close watch of the crop cannot be excepted.

- 4. It should in variably be an approved species for artificial regeneration suited for the climatic condition and soil properties of the locality. A trial and error method will be suicidal for the purpose .
- 5. It should be of of long term rotation necessitating on short term operation.
- 6. It should be on excite suitable for our soil as this will prevent squares from changing the boundaries and planting up to suitable department operation.
- 2. The disadvantage of Eucalyptus hybrid as a short rotation crop can be overlooked by resorting to coppicing. Since there would not be any sine timber at the time of following it will be easy for extraction also.
- 3. Eucalyptus hybrid is easy to raise an sure of success. It may help to meet the growing demand for firewood in the adjacent towns and village and also the demand for non durable timber for agricultural and other purposes. Eucalyptus hybrid planted in a belt of two chains width would present a clear cut demarcation an prevent tempering of boundaries and subsequent planting.
