ORDER

In the G.O. read as Ist paper above an extent of 300 acres of land in churuli Pathal was ordered to be transferred to the Revenue Department for allotment to hill men evicted from Idukki project area . It was since brought to notice of Government that there are only 39 families of hill men to be resettled and that almost all lands in Churuli Keerithode area have been utilized for resettlement of Idukki evictees excepting R.S.A. Coupe No. VII comprising of 88 acres approximately. Accordingly in the G.O. read as IInd paper above orders were issued for the transfer of 88 acres of land in R.S.A. Coupe No. VII in Churuli- Keerithode area to the revenue Department for allotment in favor of 39 hill men subject to the provisions under the Kerala Land Assignment rules. Supply Scheme- regarding

The district collector, Idukki has now reported that the land in Churuli Keerithode Coupe No. VII has been utilized for restiling persons who lost their holding in the natural calamities of July 1974 and that an extent of 208.40 areas of land remains available at churuli Pathal which may not be required for resettlement of Idukki evictees. Since the land available in Churuli pathal is more stabile for rest telling hill men he has suggested that the balance of land available in Churuli Pathal may be made available to the Hill men families and the G.O. read as 2nd paper may be modified accordingly.

Government have examined the matter and they are pleased to accord Sanction to allot 88 (Eighty eight) area of land from the remaining portion of the arable forest land in Churuli Pathal area for resettling the 39 hill- men families.

The G.O. read as IInd paper stands modified to the above extent.
