## ORDER

As per G.O. Ist read above, fifty cents of Forest land near the police station at Idamalayar, from the area already under possession of the Kerala State Electricity Board for project works, was sub-leased to Sri. K.M.Thomas, Advocate, Devicolam for a period of one year from 11<sup>th</sup> June 1975 for running a temporary cinema Theatre. Subsequently the lease was extended from time to time.

2. The lease rent was fixed at Rs.40/- per cent per year as per orders contained in G.O. cited  $2^{nd}$  above. Subsequently, the above rate of Rs.40/- was enhanced to Rs. 100/- as per G.O. cited  $3^{rd}$  above.

3. Shri K.M. Thomas the lessee in his petitions read as 5<sup>th</sup> paper above, has requested the Government not to realize the lease rent at the enhanced rate.

4. Having considered all the aspects of the question Government are pleased to cancel the enhancement of lease rent ordered in G.O.cited as  $3^{rd}$  above. The G.O. read as fourth paper will stand modified to the above extent.

The Chief Conservator of Forests will take immediate necessary action to realize the arrears of lease rent due from the lessee at the original rate of Rs.40/- per cent per annum.

5. Sanction is also accorded for the extension of the period of lease of the above paid 50 cents of land for a further period of one year with effect from 11-6-'78 at a lease rent of Rs.40/- per cent per annum.
