O R D E R

An extent of 0.62 Sq. Kilo Metre (62 hectares) is to be cleared for laying Idamalayar-Chalakudy 110 KV.Line. As clearance of forest require the approval of the Central Government the matter was taken up with Government of India. Ministry of Agriculture for their approval as per the provisions of the Forest (Conservation) Act 1980.

The Government of India in their letter read above conveyed their approval under section 2 of the Forest (Conservation Act 1980 for the release of 0.62 Sq. Kilo Metre of forest land for the above purpose, subject to the following conditions.

- i) Status and ownership of the forest land will not change.
- ii) Only minimum of trees will be removed under the supervisions of a Forest Officers.
- iii) The Forest Department should also recover the cost of raising Compensatory Plantations over an equal area and their maintenance for three years from, the Kerala State Electricity Board.

Sanction is accorded for the clearance and allotment of 0.61 Sq. Kilometre(62 hectares) of forest land laying in Thundathil Kodanad & Kalady ranges of Maslayattur Forest Division to Kerala State Electricity Board for laying the Idamalayar-Chalakudy 110 KV Line on the above conditions.

The Chief Conservator of Forests, Trivandrum will take further action in the matter.
