ORDER

In the Government Order read as fourth paper above it was inter ails ordered that the demarcation of the forest areas to be preserved as forest will be taken an immediately in the Forest Divisions of Malayattur, Kottayam, Ranni and Konni. The Director of Survey and Land Records has forwarded proposals for the additional staff and other expenditure required for the work in the forest Divisions of Ranni, Kottayam and Malayattur. Government considers that Konni division has also to be included in the scope of this survey. After having considered the matter in detail, Government accord sanction for the creation of the following additional posts for a period of three months from date of employment for carrying out demarcation of the forest areas in the above four divisions.

- 2. The training of survey staff is a requirement of the Department of Survey and Land Records. The expenditure in this connection has to be met by that Department. Hence the additional staff proposed by the Director of Survey and Land reports for the conduct of survey training class cannot be sanctioned now. The Director of Survey and Land Records may forward proposals separately top the Revenue Department, Secretariat, if Survey training classes have to be conducted to meet the requirements of his Department for survey trained staff.
- 3. Government also accord sanction for the estimate of Rs.34,440/-(Rupees Twenty four thousand four hundred and forty only) forwarded by the Director of Survey and Land Records towards Chairman wages, line clearing charges etc. A copy of the estimate is enclosed.
- 4. The expenditure will be met from the funds provided for the plan scheme "Forest Survey and Demarcation" for which there is a total provision of Rs.3.47 lakhs in the current year's budget under "70(b) (II) "and 70 (c) (V) M".
- 5. The Chief Conservator of Forests will depute an experienced Deputy, Ranger (I Grade) and 2 guards for the work immediately. He will also place immediately the necessary funds at the disposal of the Director of Survey and land Records. The superintendent of survey and Land Records to be appointed for the work in this case will be the drawing officer to operate the funds to be placed at the disposal; of the Director of Survey and Land Records by the Chief Conservator of Forests.
