### ORDER

The Deputy Conservator of Forests, Kottayam, has pointed out in his letter C4-2257/64 dated 27-4-1964 addressed to the District Collector, Ernakulum that the southern bank of Perinjankutty river, i.e., Perinjenkutty area falls within the jurisdiction of the Special Deputy Collector, Mundakayam and the northern bank, i.e., Chinnartheeram falls within the jurisdiction of the Special Deputy Collector, Vellathooval and has suggested that it would be more advantageous in preventing encroachments t, if both these areas are brought under the control of the Special Deputy Collector, Vellathooval. The District Collector, Kottayam has endorsed the recommendation of the Deputy Conservator of Forests in his letter read above, Government are pleased to accept the above proposal and they order accordingly.

The Deputy Conservator of Forests, Kottayam, has also proposed the establishment of a special unit (one Ranger, 4 Foresters and 12 Guards) so that effective steps can be taken to prevent further encroachments in the area. The District Collector, Kottayam has endorsed this recommendation for additional staff also, to prevent further encroachments in the area. The Chief Conservator of Forests has also requested Government to accord sanction for the special forest staff Viz. 1 Ranger, 4 Foresters and 12 Guards to prevent encroachments in the area.

Government are pleased to accord sanction for the creation of one post of Ranger on Rs.150-300, 4 posts of Foresters on Rs.40-120 and 12 posts of Guards on Rs.35-45 temporarily till the end of February 1965 to prevent encroachment in the area.

The expenditure on account of the posts created will be debited to the relevant head in the Budget of the Forest Department.
