ORDER

According to G.O.MS.598/68/Rev. dated 4-12-1968 read with G.O.MS.124/RD dated 7-3-1969 the 167 families to be evicted from the Kulamavu Channel area are to be resettled in the lands indicated below:-

2. As per the direction given in the Government Order read as third paper above, the Special Deputy Collector, Idikki, has inspected the areas specified at (d) above and sent up a report in his letter read as fifth paper.

3. Having examined the report, Government order that (i) The 150 acres out of 171.29 acres of land available in Blocks II and III of Kunthirimudi area in Chully section of Kalady Range in Chalakudy Forest Division which now stand allotted to Harijans as per G.O.MS.304/68/Agri. dated 17-6-68 read as fourth paper above will be utilized for the resettlement of the evictees from Kulamavu Channel areas ordered in G.O.MS.120/69/RD dated 26-3-69 and G.O.MS.124/69/RD dated 7-3-1969.

(ii) The occupants on Nachar river area and the tail race tunnel area of Moolamattom in Idikki Project area will be evicted and resettled on 30-39 acres of land in Chanthamattom in Block C in M.F.S. coupe No.V in Thodupuzha Reserve Forest in

Kothamangalam Range on the same conditions adumbrated in G.O.MS.476/68/RD dated 26-9-68 as amended by G.O.MS.120/69/RD dated 26-3-69 and G.O.MS.124/69/RD dated 7-3-1969.

4. Orders regarding the transfer to the Revenue Department of the land referred to in Para 3 above and also amending G.O.MS.304/68/Agri. dated 17-6-1968 will be issued separately by Government in the Agriculture (Forest) Department.

5. The Assistant Director of Survey and Land Records Trichur will make necessary arrangements for the survey and sub division of the lands in consultation with the Special Deputy Collector, Idikki.
