ORDER

In the Government orders read as second and third Paper above, sanction was accorded for the disseveration and transfer of 1500 acres of forest lands in Kaliyar Kothamangalam Range, Industrial Plantation Division, Perumbavoor and 1400 acres of forest lands in Chethakal Reserve, Ranni Division to the Revenue Department for resettlement of evictees from Idikki Project area. The Special Deputy Collector, Iddikki has reported that besides the areas mentioned above, additional areas are required for the purpose. The District Collector, Ernakulam has endorsed the above views of the Special Deputy Collector Idikki.

Governments have considered the proposal and are pleased to order for the disseveration and transfer of the areas detailed below to the Revenue Department for resettlement of the evictees from Idikki Project area.

1. Munnar.	Pancmkutty in Nagarampara Adimali Range	696 acres.
2. Malayattoor.	Illichery and Nellapara.	500 acres.

In the Government Order read as fourth paper, above sanction was accorded for the disseveration and transfer of 3750 acres of forest land in Churuli Keerithode, Nagarampara Range, Kottayam Division to the Revenue Department. Of this 900 acres of land were ordered to be set apart for assignment to the old settlers of the area and remaining area of 2850 acres to be distributed under "Arable land Distribution Scheme".

In modification of this Government Order sanction is also accorded for allotment of the remaining area of 2850 acres of forest land mentioned above for resettlement of the evictees from Idikki Project area.

The Chief Conservator of Forests will take immediate necessary action for the transfer of the areas to the Revenue Department after removal of tree growth.

Government will be removed for necessary orders if additional land is required for the purpose.
