Sub: Forest (Conservation) Act, 1980 – Procedure for obtaining the prior Approval of the Central/Government under section 2 thereof

Under section 2 of the Forest (Conservation) Act, 1980 prior approval of the Central Government is essential before dereserving any "Reserved Forests" or making use of any forest land for non-forest purposes. Proposals for dereservation hectare required to be forwarded by State Governments /Union Territories in the Proforma act along with this Ministry letter of even number dated, 26-12-80.

- 2. It has come to the notice of this Ministry that in some states individual department have been authorized to forward proposals relating to forget are obtaining no objection Certificate from the Forests Department. This procedure is not correct-it is the administrative responsibility of the Forests Department, which is the rural custodian and owner of the Forests in each state to correspond with the Central Government regarding transfer of forests areas etc. under the Act. It will not be proper to shift this responsibility to other Departments of the State, after issuing a no-objection certificate. It is noteworthy that even when the Central Government given its approval, it is conveyed direct to the State Forest Department which is responsible for effecting the transfer of the forest areas to the party concerned.
- 3. It has accordingly been decided that proposals for dereservation etc. under the Forest (Conservation) Act 1980, will be entertained by this Ministry only from the Forest Departments of States/Union Territories.
