ORDER

As per G. O. referred 1st above Government have enhanced monetary limit prescribed under Rule 42 (b) 1 of Appendix 3, KTC Vol. II in respect of payments of balance amount in the Savings bank deposit due to legal heirs of deceased depositors on the strength of heirship certificate issued by Tahsildar concerned.

2. The ceiling was fixed seven years ago and Director of Treasuries has now requested Government to enhance the monetary limits prescribed.

3. Government have examined the matter in detail and are pleased to order as follows:

The amount specified in Exception 1 under Rule 42 (b) 1 of Appendix 3, KTC Vol. II will be enhanced from ₹ 75,000 to ₹ 1,00,000 and the monetary limits of ₹ 75,000 and ₹ 1,00,000 specified in Exception 2 thereunder will be enhanced to ₹ 1,00,000 and ₹ 2,00,000 respectively.

4. Amendment to Rules in KTC Vol. II will be issued separately.
