ORDER

AMENDMENT

(C.S. No. 1/2012)

Article 245 A

The following shall be substituted in Article 245 A of Kerala Financial Code Volume I:

1. The figure '25,000' occurring under the caption 'D. Marriage Advance' in Article 245 A shall be substituted by the figure '30,000'.
2. The figure '9%' occurring in Article 245 A below the sub-heading 'Interest' shall be substituted by the figure '8%'.
