Departmental Vehicles – Purchase of Petrol, Oil, and Lubricants from bunks of Kerala State Civil Supplies Corporation Limited – Enhancement of amount to be deposited by departmental Officers who intend to start fresh accounts with the Kerala State Civil Supplies Corporation – Approved – Orders issued.

ORDER

In the G.Os. read above the Heads of Departments and Offices of Trivandrum, Quilon, Kottayam and Ernakulam Districts had been given sanction to draw an amount equal to 50% of the monthly average expenditure on purchase of petrol, Oil and Lubricants and to deposit it with the Kerala State Civil Supplies Corporation Limited subject to the condition that the advance deposits made by the departmental officers will be adjusted against the final bill due for that month itself and that further advance will be drawn only after previous advance has been fully adjusted by bills and vouchers. The Managing Director, Kerala State Civil Supplies Corporation in the letter read as third paper above has reported that huge amounts are pending realization from various departments towards the cost of Petrol, Oil and Lubricants purchased for the departmental vehicles. So as to reduce the loss sustained by the Kerala State Civil Supplies Corporation on account of delayed payment the Managing Director has suggested that departmental Officers who want to start fresh accounts with the Corporation in future be asked to deposit either Rs.2500/-- or the amount equal to the cost of petrol, Oil & Lubricant that they will draw in a month whichever is higher.

2. Government have examined the above proposal in detail. Sanction is accorded to the Departmental Officers who want to purchase petrol, Oil & Lubricants from the bunks of the Kerala State Civil Supplies Corporation Ltd., by starting fresh accounts, to deposit with the Corporation either Rs.2500/- or the amount equal to the cost of petrol, oil, Lubricants that they will draw in a month, whichever is higher. The deposits will be adjusted every month as ordered in the G.O. read as second paper above.
