ORDER

The Committee of Secretaries constituted as per the G.O. cited for scrutinizing proposals for additional staff has brought to the notice of Government that the work of the committee gets delayed because of non-receipt of redeployment proposals from departments. The following further instructions are issued in order to make the work of the Committee effective:-

- (i) All proposals received from departments for creating additional posts will be initially analysed by Finance Department in the context of existing posts within the department. In cases of difficulty in coming to definite conclusions the workload and possibilities of redeployment will be scrutinized and analysed by the staff attached to Secretary (P&ARD) if necessary, by visiting the various offices and collecting details.
- (ii) Proposals for creating posts in the Class IV category will not be considered by the committee. Similarly isolated posts which do not have a redeployment angle need not be placed before the Committee. All such cases will be considered by the Finance Department applying rigorous yard-sticks.
- (iii) The Commissioner & Secretary (Finance) will also be a member of the Committee.
- (iv) The Secretarial service, required for the conduct of work-study to be undertaken for the purpose will be provided by the existing staff attached to the Personal & Administrative Reforms Department.
- (v) This will take effect from 1-4-1987.
