ORDER

The Chief Conservator of Forests has brought to the notice of the Kerala State Electricity Board, that consequent on felling of trees by the Board along the alignment of the Neriamangalam-Alwaye 110 K.V. Line without proper care, extraction of certain logs has been rendered difficult and that damages have occurred to certain other logs. The Chief Conservator of Forests proposes to work down teak and rosewood logs, to the depot and to dispose of the rest in auction. The value of the materials to be disposed of in auction is estimated at Rs.27,740/-. As the logs have been damaged the Chief Conservator of Forests fears short-fall of revenue when the timber and firewood are sold. He has therefore requested the Board to make good to the Forest Department any shortfall below the estimated rate, as the sale is being hastened up for the Board's convenience.

- 2. The Board has objected to this claims and has requested Government to direct the Chief Conservator of Forests to withdraw the claim. Government are of the view that if the Forest Department had undertaken the work, the question of any loss of revenue would not have arisen, and in the circumstances they order that such loss if any has to be met by the Board. The loss should be worked out by deducting the net sale proceeds from the cost of the timber calculated at scheduled rates minus cost of transport which should be to the depot or point of sale wherever it is.
- 3. The Chief Conservator of Forests has issued orders to the Divl. Forest Officer to work down the saleable teak and rosewood logs to the depot. In the data forwarded by him, there are no sanctioned schedule rates for items 3 to 7. Government are pleased to approve these rates in the data.
