ORDER

The Accountant General has suggested that the value of tender forms in the Forest Department may be fixed at the same rates as was sanctioned as per G.O.L.Dis.3493/56/PW & C dated 19-6-1956 for the P.W.D. He has also enquired whether this may not be done by an executive order without waiting for the enactment of the Kerala Forest Act. He has also enquired whether the orders issued as per G.O.Ms.419/PW dated 8-11-1960 extending the scope of the orders dated 29-6-56 to the whole State apply to the Forest Department as well.

Government have considered the question and are pleased to order that cost of tender forms for Forest Contracts will be fixed at the same rates ordered in G.P.D.Dis.3493/56/P&C dated 29-6-1956 viz:
