ORDER

The comptroller has in his letter read above recommended that the procedure prescribed by the Government of India in G.M.No.18(3)-E-II(A) 59 dated 3-12-59 for sanctioning payment of arrear claims which cannot be verified by audit due to the limited period of preservation of records, may be accepted for adoption in this State also. The Government after closely examining the recommendation are pleased to issue the following instructions for the guidance of all concerned.

1. Since audit is not in a position to verify the accuracy and admissibility of time-barred claims the administrative authorities should satisfy themselves in these respects before authorizing payment. The Finance Department should also be consulted before authorizing payment.
2. The Administrative authorities should check up a claim with reference to the relevant records.
3. The Administrative Department in the Secretariat should while forwarding such claims for consideration of the Finance Department furnish full particulars of the claims in the proforma appended.
4. They should also certify that the accuracy and admissibility of the claim have been checked with reference to the corroborative records and that it has not been paid earlier.

Necessary amendments to the Travancore Financial and Account code will be issued separately.
