Item 8: watering Eucalyptus nursery at the rate of 30 litres per sq. metre for 400 seedlings in a seed bed or 200 seedlings in polythene bags of dimensions 12 cm x 18 cm (lay flat) for a lead of 100 metres from source of water. For extra lead add 20% for every 50 metres of addl. Lead for a maximum lead upto 500 metres.

Item 20: Transport of seedlings in Polythene bags to planting sites and distribution upto a lead of 50 metres from nursery site. For extra lead add 20% for every 50 metres of addl. Lead upto a maximum lead off 500 metres.

Apart from the above, one more item may also be included viz.,

Watering Teak nursery to Facilitate pulling out teak Seedlings during dry weather Upto a lead of 100 metres.	} Standard time (Minutes) 11	Unit. Sq. M.	Output per worker per day (420 minutes) 38 Sq.M.(ie. 2 ½ 2 ½ Std. bds/day/worker.

For every addl. Lead of 50 metres, add 20% to the above upto a maximum lead of 500 metres.
