ORDER

In the G.O. read as first paper above, Government have ordered that the candidates from this State undergoing the third year Diploma course at the Indian Forests College, Dehra Dun will be treated as in State Service and granted the pay and allowances including the leave etc admissible to the Assistant Conservator of Forests in this State. The Accountant General in his letter read above, has raised the question whether the third year course will count for increment in the scale of Asst. Conservators of Forests.

- 2. IN connection with the framing of draft rules for the Kerala Forests Services, it has been decided that the Asst. Conservators of Forests, recruited direct shall be on probation for a total period of three years from the date on which they pass the Second year course in the Indian Forests College Dehra Dun. Their probation therefore commences from the third year in the Forest College if they pass the second year course. According to the definition in the State and subordinate rules a person is said to be on duty as a member of a service when he is performing the duties of the post on the cadre of such service or as undergoing probation, instruction on training prescribed for such services, The probationary Asst. Conservator of Forests will thus be deemed to be on duty with effect from the date of commencement of their probation in their post and will be eligible for increment on that basis.
- 3. Formal orders prescribing three years of probation for the Asst. Conservators of Forests from the date of passing the 2^{nd} year of the Diploma course in Forestry will issue separately.
- 4. The orders in G.O. Ms. 946/Pub (Services) dated 2-11-1959 do not refer to cases where probation extends to three years. In such cases, the first and second increments will be allowed after putting the necessary services to earn increments. But the third increment will be allowed only after the date on which the persons concerned is declared to have completed his probation satisfactorily.
