ORDER


In the Government Order read fourth, personnel who were enlisted in the disbanded Special Armed Police II Battalion and who later joined various State Government Departments other than the Police Department were allowed to count their past service in the Special Armed Police II Battalion, for the limited purpose of increment and pensionary benefits as in the case of those mentioned in the orders read first to third. Many Heads of Departments have raised the doubt as to whether persons re-appointed in various departments, on removal from service from S. A. P. II. Battalion following disciplinary action, are also eligible for the benefits contemplated in the G. O. 4th read.

2. Former S. A. P. II Battalion Personnel re-appointed in various Departments consequent on the disbandment of the Battalion belong to the following two categories.

- (i) those rendered jobless due to the disbandment of the Battalion and
- (ii) those removed from service following disciplinary action.

3. Government are pleased to clarify that the second category of persons mentioned above, i.e. personnel who have later joined various State Government Departments after removal from service in the Battalion following disciplinary action, will not be eligible for the benefit contemplated in the G.O. fourth read.
