ORDER

In the G.O. 4th read, Government have issued amendment to Rule 10, Appendix XII-A, Kerala Service Rules as a Note in order to specify that leave to take up employment abroad or within the country sanctioned prior to 16-12-1983 and extending thereafter will not attract the provisions in Appendix XII A. But it has come to the notice of Government that because of the proviso in the Note, there has been some confusion. The intention behind the introduction of the Note under Rule 10 was to mitigate the hardship of officers on leave under the G.O. 1st read being denied promotion chances during the currency of such leave even if it extends beyond 16-12-1983.

Government have since examined the matter at length. It has been decided to delete the proviso in Note below Rule 10 to Appendix XII A, Kerala Service Rules so that those who were on leave to take up employment abroad or within the country before the commencement of Appendix XII A Kerala Service Rules are not denied their promotion chances. Government are pleased to order accordingly.

Formal amendment to Rules will follow.
