ORDER

As per Government Order read as 3rd paper above, Government have ordered to sanction family pension to the unmarried daughters above the age of 25 years for the period till they get married, amending the Rule 90 (7) (C) of the Kerala Service Rules Part III, on production of a Certificate from the Revenue Authorities to the effect that she was solely dependent on her parents and that she had no independent income.

2. As per the G. O. cited as 1st paper above, minimum family pension was sanctioned to spouses/children/parents, as the case may be, in respect of those who retired or expired prior to 1-4-1964 and those who opted out of the Liberalised Family Pension Scheme.

3. In the G. O. cited as 4th paper above, it was clarified that the benefit of G. O. second cited was not applicable to the unmarried daughters of the Family Pensioners coming under G. O. dated, 11-2-1986.

4. Government have since received a lot of representations from the unmarried daughters of family pensioners for the family pension as contemplated in the G. O. (P) No. 2007/98/Fin. dated 31-8-1998, who were receiving Family Pension under G. O. (P) No. 146/86/Fin. dated 11-2-1986.

5. Government have examined the matter in detail and are pleased to order that Family Pension is payable to the unmarried daughters of Family Pensioners of the scheme introduced in 1986, subject to the conditions specified in the G. O. second cited and as modified/clarified in G. O. cited as fifth paper above.

6. These orders will have effect from 1-4-1998. However the family pension will be payable from the date of receipt of the application form in complete shape as was ordered in the G. O. cited as 2nd paper above, while Liberalised Family Pension was extended to them.
