ORDER

As per the letter read 1^{st} paper above, Government of India issued General approval under Section 2 of the Forest (Conservation) Act 1980 for the diversion of forest land to Government departments on specific conditions.

- 2. The Chief Conservator of Forests (Special Afforestation) & Nodal Officer, Thiruvananthapuram as per the letter read 2nd paper above has forwarded a proposal for the diversion of 0.018 ha of forest land under Section 2 of Forest (Conservation) Act 1980 for laying LTOH power line for the purpose of electrification of Sivapuram Harijan Colony in Anchal Range. The Kerala State Electricity Board through the Assistant Engineer, Electrical Section, Kulathupuzha is the user agency.
- Government have examined the matter in detail and are pleased to accord sanction for the diversion of 0.018 ha of forest land under Section 2 of Forest (Conservation) Act 1980 for laying LTOH power line for the purpose of electrification of Sivapuram Harijan Colony in Anchal Range in favour of Kerala State Electricity Board through the Assistant Engineer, Electrical Section, Kulathupuzha (User agency) subject to the following conditions.

1. The legal status of the forest land shall remain unchanged

2. The forest land required for the purpose shall not exceed 0.018 ha that has been proposed

3. The User Agency shall be responsible for any loss to the flora and fauna in the surrounding and shall take all possible measures to conserve the same.

4. The User Agency shall pay the Net Present Value of the diverted forest land to Ad-hoc CAMPA account.

5. The forest land shall not be used for any purpose other than that specified in the proposal.

6. Once the purpose is served, the land will be resumed to the Forest Department.

7. Any other condition that the State Forest Department/State Government or the concerned Regional Office may impose from time to time in the interest of conservation, protection and/or development of forests.
