Read:—Letter No. FMI/1-5/95-96/809 dated 20-3-1996 from the Accountant General (A&E), Kerala, Thiruvananthapuram.

ORDER

The Accountant General (A&E), Kerala, in his letter read above has pointed out that there are several instances of violation of Government Decision 2 (ii) under Rule 16 (1) of General Provident Fund (Kerala) Rules which prohibits drawal of Temporary Advance without observing the time gap of 6 months from the grant of previous Temporary Advance. Non furnishing of previous Temporary Advance to the sanctioning authority is attributed to be the main reason for such irregular sanction/drawal.

Government have examined the matter in detail and are pleased to order that after item 4 in Form 'C' (Form of sanction for Temporary Advance from General Provident Fund) three more columns will be added as indicated below:

4 (a) Number and date of granting previous Temporary Advance.

(b) Amount of previous temporary advance.

(c) Date of the previous Temporary advance.

Government also order that a statement showing the credit balance (in the proforma prescribed in Circular No. 75/93/Fin. dated 9-11-1993) based on which the Temporary Advance has been sanctioned should be forwarded to the concerned Treasury and Accountant General's Office along with the sanction order.

Necessary amendment to Form 'C' of General Provident Fund (K) Rules will be issued separately.
