ORDER

In the Government Order read as 1st paper above, Government issued orders permitting those employees who were in service prior to 1-9-1984 to join the Group Insurance Scheme and allowing all subscribers to take more than one unit, if required, subject to the condition that the deduction should be effected at full rate in the salary of September 1995 itself.

2. In the Government Order read as 2nd Paper above, Government had ordered that the time limit will be extended from September 1995 to March 1996. A further extension of time ordered in the Government Order read as 3rd paper above has expired on 31-3-1997. Since then Government had been receiving requests from several individuals for giving one more chance to those employees who were in service prior to 1-9-1984 to join the Group Insurance Scheme.
