<u>ORDER</u>

National e-Governance Division, Department of Information Technology, Government of India has constituted State e-Governance Mission Team (SeMT) in all States and Union Territories to provide technical and managerial consultancy services to the State Government for the projects under National e-Governance Plan (NeGP) and other major State e-Governance initiatives. As per the DIT guidelines, State e-Governance Mission Team– Kerala (SeMT-K) will support the State Apex Committee constituted in the State as per Government order read as 1st paper above and function as full-time internal advisory body in undertaking e-Governance projects. The team would be responsible for undertaking the groundwork for providing an overall direction, standardization and consistency through program management of the e-Governance initiatives in the State. SeMT provides advice to the departments to implement their Mission Mode Projects (MMPs). SeMT also has the responsibility of ensuring that the different e-Governance projects being developed are in alignment with the overall objectives of National e-Governance Plan (NeGP).

SeMT is already involved in most of the MMPs being implemented by various departments, based on interactions with officials at various levels. For the projects started recently, the role of SeMT is clearly defined and SeMT is appropriately placed for advising high level committees.

SeMT shall contribute to a great extent in the decision making process of the high level committees in the departments steering the implementation of MMPs in the State,

focusing the alignment with the overall objectives of service orientation of NeGP and maximum utilization of core and support infrastructure.

As per the letter read as 2nd paper above, the Principal Consultant & Head, SeMT-K has requested that necessary directions may be issued to the Departments for availing the service of the SeMT-K for the successful implementation of MMPs in the State.

In the circumstances, Government have examined the case in detail and are pleased to order as follows:

- SeMT will support the State Apex Committee and function as advisory body in undertaking e-Governance projects as envisaged by Department of Information Technology, Government of India in "Guidelines for Capacity Building and institutional Framework for e-Governance under NeGP.".
- All the Departments / PSUs/Autonomous bodies, involved in implementation of MMPs should ensure the involvement of SeMT-K at the internal advisory level to the decision making authorities of various departments for the successful implementation of MMPs in the State.
