ORDER

In the Government Order read as fifth paper above, Government have sanctioned ad-hoc bonus/festival allowance to the State Government employees and the staff of aided educational institutions at the rates and subject to the conditions special therein.

2. Government are now pleased to order that all employees who are not eligible for ad hoc bonus sanctioned in the G.O. read as fifth paper above, but who are eligible fore Special Festival Allowance as per the Government orders read as first, second, third and fourth papers above, and those who were sanctioned Special Festival Allowance last year, shall be granted Special Festival Allowance as per the terms and conditions in the Government Orders read as 1st and 2nd paper above for the year 1986-87, as in pervious years, at the following revised rates.

Amount of Special Festival Allowance for 1986-87

(i) for those getting Rs. 200	Rs.300
(ii) for those getting Rs.110	Rs.165
(iii) for those getting Rs.75	Rs.115
(iv) for those getting Rs.55	Rs.85

3. The Special Festival Allowance shall be drawn and disbursed on or before 10-9-1986. If due to any valid reason, the Special Festival Allowance is not drawn and disbursed to any entitled individual before the stimulated date; it shall be granted at any time during the current financial year.

- 4. In respect of those who are entitled for both ad hoc bonus and Special Festival allowance they will have the option tom choose either of the two.
- 5. The general conditions stipulated in the Government orders read as first and second papers above for the drawls of special festival allowance will be applicable during 1986-87 also.
