Abstract

Forests – Collection and transport of saplings from plantations – Inclusion of clause 45 in the agreement making the contractor liable for low sales – Exemption ordered.

ORDER

Agreement for a certain contract for transport and delivery of thinned materials from plantation was executed with a close (clause 45) making the contractor liable if any of the logs of saplings on sale did not fetch an amount equal to kalavila plus seigniorage. As the contractor was transporting only those saplings entrusted to him by the Departmental Officer and as he had no control over the sales, Government issued orders in the memorandum cited that the amounts due to the contractor would be paid to him under the conditions of the agreement but for the inclusion of clause 45. The Chief Conservator of Forests has now reported that there are similar supply contracts in his department having the very same clause incorporated in the agreements. He requests orders whether the above orders can be made applicable to those contracts having the very same clause so as to effect uniformity and equity.

In the spirit of the orders issued in memorandum No.19681/57/Agri. dated 2-11-1960, Government are pleased to order that the liabilities of the contractors who have taken up similar contracts for transport and delivery of saplings from plantations with similar provision in the agreements will be settled according to the terms of the agreements but for the inclusion of clauses 45 in the agreement.
