Please refer to your letter cited. The modus operandi for filing a Civil suit against a party by Government is not ostensibly soon followed from that end. The relevant rules are laid down in G.O.(P)11/78/Law dt. 25-01-78. According to the said rules whenever the State Government of the Officers working on their behalf end to file a civil suit against a party, the facts necessitating the filing of the suit are to be given in a detailed manner or more appropriately in the form of a para - war statement of facts and the same has to be forwarded to Government through the head of Department for their approval. There upon, the Government in the Administrative Department, shall forward the approved statement of facts and relevant records of the case to the concerned Government pleader for repairing the plaint conforming in material particulars to the statement of facts already approved by Government . the Government Law officer shall then forward the plaint to the Collector or verification and signature. However, if the Government law officer deviates in material particulars from the statement of facts, the plaint prepared by him should be subjected to further scrutiny and approval by Government. If the plaint prepared by the Government Law Officer agrees to the materials particulars in the statement of facts approved by Government the same will be duly signed and returned to him for being filed in Court. Thereafter the Head of Department has to arrange through the local officers of the department for giving necessary instructions and other assistance to the Government Pleader for the conduct of the case at all stages.

In view of the above regulations, I request you to arrange to forward a complete and detailed statement of facts of the case along with the relevant records to the Head of Department for getting the same approved by Government in the Administrative Department for further course of action as stated above so that the proposed civil suit against the defaulter in this case can be instituted as desired by you, without procedural flows.
