



O R D E R

The Chief Conservator of Forests in his letter read as first paper above has submitted 4 proposals for diversion of forest land for collection of rubbles/building stones of Chalakkudy division (6.43ha. - two sites), Malayattoor division (6.56ha. - three sites), Kalady division (6.60 ha. - two sites) and Thrissur division (10.14 ha. - six sites). Government of India in their letter read as second paper above have conveyed their final approval under Section - 2 of the Forest (Conservation) Act, 1980 for diversion of forest land for the collection of rubbles, granite/building stones in the above divisions.

In the circumstances, Sanction is accorded for diversion of forest land of Thrissur division (10.14 ha. at six sites - (1) Vengappa I - 1.85 ha., (2) Vengappa II - 0.95 ha., (3) Thonippara - 2.35 ha., (4) Kundukad - 4.00 ha., (5) Oorakkad - 0.18 ha., (6) Nilappanapara - 0.81 ha.),

Kalady division (6.60 ha. at two sites- (1) Padappara I - 4.425 ha., (2) Padappara II - 2.1811 ha.), Chalakkudy division (6.43 ha. at two sites (1) Kanakamala - 2.72 ha., (2) Mattathur - 3.71 ha.) and Malayattoor division (6.56 ha. at three sites - (1) Vellachal west - 4.84 ha., (2) Vellachal East - 0.52 ha., (3) Karakkad - 1.20 ha.) for collection of granites/building stones for a period of five years with effect from 22.4.99 on the following conditions:

- (1) Legal Status of Forest land shall remain unchanged.
- (ii) Compensatory Afforestation (CA) over 59.47 ha. of degraded forest area shall be done by forest department within a period of two years.
- (iii) Penal Compensatory Afforestation over 59.47 ha. of degraded forest area shall be done by Parent Department within a period of two years.
- (iv) Rubbles may be collected through Forest Department or ~~Forest~~ ✓ Forest Development Corporation of the State Government of Kerala. The Department of Forest & Wild Life shall issue detailed guidelines to regulate removal of rubble from forest area with adequate safeguards.
- (v) The consent of State Pollution Control Board will be obtained under the Air (Prevention and Control of Pollution) Act 1981 and the water (Prevention and Control of Pollution) Act 1974 before commencement of mining operation.
- (vi) Any other conditions to be stipulated by the State Government in the interest of Conservation/Preservation of Forests.

The Principal Chief Conservator of Forest (D&P) will take necessary steps to see that the above conditions are

have conveyed its general approval under section 2 of Forest (Conservation) Act, 1980 for diversion of forest land for under ground laying of optical fiber cables, telephone ^{lines} and drinking water supply pipelines subject to certain conditions.

The Chief Conservator of Forests (P) in his letter read as second above has recommended a proposal for diversion of 0.08772 ha (x length of trench ^{dimensions} are 2.924 KM with diversion 100 CM X 30 CM) of forest land for laying under ground cable through the side of forest roads in Machad Range in Thrissur Division.

Government have examined the proposal in details ^{and} are pleased to accord sanction for the permissive use of 0.08772 ha (length of the trench ^{dimensions} are 2.924 KM with diversion 100 CM X 30 CM) of forest land in Machad Range, in Thrissur Division for laying under ground cable through the side of forest roads in Machad Range subject to the following conditions.

- i. Legal status of the forest land shall remain unchanged.
- ii. The maximum length of the trench will be 2.924 Kms with dimensions 100 CM X 30 CM.
- iii. The User agency agrees to make good the land after use/^{maintenance}.
- iv. The User agency agrees to make good any loss to forest/environment.
- v. The User agency seeks permission from local forest department for carrying out any maintenance.
- vi. No trees are cut/tilled down for the purpose.
- vii. Any other conditions to be stipulated by the State Government/Prl. Chie conservator of forests in the interest of

viii. Any deviation from the above conditions will require separate submission of proposals/permission under Forest Conservation (condition) Act, 1980.
