S.R.O. No.1148/80- In exercise of the powers conferred by sub section (1) of Section 3 of the Kerala forest Produce (Fixation of selling price) Act 1978 (29 of 1978) read with sub-section (4) of the said section and in super session of the notification issued under Notification G.O. (Ms) No. 117/80/AD dated 31st march 1980 published as S.R.O No. 342/80 in the Kerala Gazette Extraordinary No. 249 dated 31st March 1980, the Government of Kerala having it necessary so to do and after having consulted the Expert Committee constituted under section 4 of the said act and having considered the recommendations made by it hereby refix the selling price of forest produce as specified in the schedule below for the remaining part of the financial year 1980-81.

The following formula will be adopted for correction of loss of weight after felling:-

- (1) Weight recorded on or before the thirtieth (30th) day of felling will be treated as such
- (2) Weight recorded after thirtieth days of felling will be multiplied by 10/6.
- (3) Weight recorded after 75 days from the date of felling will be doubled.

Note: (i) In relation to all the species, the price of billets/ firewood with bark will be per species tonne. 1/3 of the price fixed per cubic metre for standing – timber of the same species, would be realized for stacked tonne of billets/firewood on unless otherwise specified.

(ii) The price will apply to sound timber only, short length logs and unsound timber (rejection) will be auctioned by the Forest Department.

Explanatory Note

The Government of Kerala constituted an Expert Committee under section 4 of the Kerala for produce [Fixation of selling price] Act, 1978, as per Gazette Notification. S.R.O No. 1218/78 dated 26-12-1978. Having considered the recommendations of this committee for fixation of price of produce, Government issued Notification GO(Ms)117/80/AD dated 31-3-1980 fixing the selling price and forest produce for the financial year 1980-81as required under sub-section (1) of under section 3 of the above mentioned Act. Government have considered the recommendation of the committee which met on price of the Forest Produce for the financial year 1980-81 as recommended by the Committee under sub section 4 of section 3 of the Act. The present notification is to notify the refixed price of the forest produce to the public.

S.R.O. No.1149/80- In exercise of the powers conferred by sub section (6) of the Kerala forest Produce (Fixation of selling price) Act 1978 (29 of 1978) the Government of Kerala, being satisfied that it is necessary so to do in the public interest, hereby exempt the sale of any forest produce to the Kerala Newsprint Project under the Hindustan Paper Corporation, the Kerala State Bamboo Corporation and the Travancore Plywood Industries, Punalur from the provisions of section 5 of the said Act.

Explanatory Note

After Government have notified selling price of Forest Produce Section 3 of Act 29 of 1978, Forest Produce cannot be sold at price less than the selling price. Under section 6 of the Act, Government exempt in public interest, by notification, the sale of any Forest duce to companies owned by the central Government or by Government of Kerala. As Kerala Newsprint Project, Bamboo Corporation and the Travancore Plywood Industries, Punalur are undertakings of the Central Government and the Government of Kerala respectively, it is considered expedient to exempt these from the provisions of section 5 of the Act. The Notification is intended to achieve the above purpose.
